APPLICATIONS FOR ANY COMPANY

- 1. Protecting executive communications among themselves, to subordinates, to board members
- 2. In engineering/R&D to protect intellectual property
- 3. In sales and marketing to protect Customer Lists and Pricing information
- 4. In customer support to secure service notes being delivered to service centers
- 5. In human resources to protect employee's personal information
- 6. In human resources to protect organization charts, pay scales, performance evaluations
- 7. In finance to protect financial statements not yet published
- 8. In finance to protect information being presented to auditors
